### Annulement proceedings

Denis has carried out more then ten annulment proceedings in relation to national and international arbitral awards and is a regular advisor on this issue. For instance, Denis has just been appointed by the European Union in an annulment procedure brought against the EU by a Cypriot company (confidentiality rule applies).

Several annulment proceedings in relation to in national arbitrations or in international arbitral awards concerning exclusive sales concessions ; a very important subject in Belgium because the law is a matter of public policy, substantially protects the distributor, and retains the exclusive jurisdiction of the courts to the exclusion of arbitration.

# **Arbitration Experience**

Denis has acquired an experience in arbitration since decennia.

As arbitrator:

- Co-arbitrator in ICC proceedings more than ten times since 1988 (share purchase agreement for the sale of a bank in Luxemburg by a Middle East holding company in 2018; joint venture contract in 2000 between a Lithuanian company and a Norwegian company...)
